#### **ANNEX I:**

Littly Type and	Definitions.
Banks:	A bank is a financial institution licensed to receive deposits and make loans. Banks may also provide financial services, such as wealth management, currency exchange and safe deposit boxes. Includes all Jordanian and non-Jordanian deposit money banks operating in the Kingdom. This definition does not include financial institutions

Governmental or

organizations:

Entity Type and Definitions:

Entities that the Government of Jordan owns at least 50% share of, or entities that receive at least 50% of their financial support from the Government of Jordan.

#### **Utilities:**

Any organization, which provides services to the general public, although it may be privately owned. Public utilities include electric, gas, telephone, water, and television cable systems, as well as streetcar and bus lines. They are allowed certain monopoly rights due to the practical need to service entire geographic areas with one system, but they are regulated by state, county and/or city public utility commissions under state laws.

# Civil society Organizations (CSO):

"Civil society" is defined broadly as "non-partisan and non-governmental organizations promoting an interest benefitting a common good." Civil society organizations are distinct from political parties in that they do not share the objective of striving for political office. CSOs operate at the governorate level or national-level.

## Community Based Organization (CBO):

Registered as a non-profit society or non-profit company with headquarters based in Jordan; operates locally at the community level, municipal level or in one governorate, mainly membership and volunteer based with limited outreach

#### **DPO**:

Representative organizations or groups of persons with disabilities (PWDs), where PWDs constitute a majority of the overall staff, board, and volunteers are well represented in all levels of the organization. Where a primary aim of these organizations is empowerment and the growth of self-advocacy of persons with disabilities.

### Unions and Professional Associations:

(Unions a group of workers joined in a specific type of organization for the purpose of improving their working conditions as well as to help in promoting the common interests of the group. // Professional Associations: A professional association is usually a nonprofit organization seeking to further a particular profession, the interests of individuals engaged in that profession, and the public interest

Educational An educational institution is a place where people of different ages gain an education, including preschools, child care, elementary schools, and universities. A research institute is an establishment endowed for doing research.



Households:	A household includes all the persons who occupy a housing unit. A housing unit is a house, an apartment, a mobile home, a group of rooms, or a single room that is occupied
Monetary Financial Institutions:	"Monetary financial institutions" (MFIs) are central banks, resident credit institutions as defined in Community law, and other resident financial institutions whose business is to receive deposits and/or close substitutes for deposits from entities other than MFIs and, for their own account (at least in economic terms), to grant credits and/or make investments in securities. Money market funds are also classified as MFIs.
Public Health Facilities:	A Health facility is, in general, any location where healthcare is provided. Health facilities range from small clinics and doctor's offices to urgent care centers and large hospitals with elaborate emergency rooms and trauma centers.
*Under Others:	
Informal/Non- Registered Group:	No registration; community or activist group pursuing a cause or common interest.
Coalitions:	A coalition is defined as two or more organizations (CSO, private organization, media or governmental organization) with at least one of the members being a civil society organization, working together for a common goal over either the long- or short-term.
